



## § 1 Information about the collection of personal data

- 1. Below we inform about the collection of personal data when using our website. Personal data is all data that can be personally referred to you, such as name, address, e-mail address, usage behavior, etc.

- 3. When you contact us by e-mail or through a contact form, we will store the information you have provided (your e-mail address, your name and telephone number if applicable) to answer your questions. We delete the data that arises from this context after the storage is no longer required, or limit the process if there are statutory retention requirements.
- 4. If we rely on commissioned service providers for individual functions of our offer or if we wish to use your data for advertising purposes, we will inform you in detail below about the respective transactions. In doing so, we also name the specified criteria for the storage duration.

### § 2 Collection of personal data when visiting our website

- 1. In the merely informative use of the website, i.e. if you do not register or otherwise provide us with information, we will only collect the personal data that your browser transmits to our server. If you visit our website, we collect the following data that is technically necessary for us to display our website and to ensure the stability and security (legal basis Art. 6 para. 1 p. 1 lit.f. DSGVO):
  - IP address,
  - date and time of request,
  - time zone difference to Greenwich Mean Time (GMT),
  - content of the request (concrete page),
  - access status / http status code,
  - each transferred amount of data,
  - website from which the request comes
  - browser, operating system and its interface,
  - language and version of the browser software
- 2. In addition to the aforementioned data, cookies are stored on your computer when you use our website. Cookies are small text files that are stored on your hard drive assigned to the browser you use and through which entity that sets the cookie (in this case, through us). Cookies cannot run programs or transmit viruses to your computer. They serve to make the Internet more user-friendly and overall effective.



#### 3. Use of cookies:

- a) This website uses the following types of cookies, the scope and function of which are explained below:
  - Transient cookies (see b)
  - Persistent cookies (see c)
- b) Transient cookies are automatically deleted when you close the browser. These include in particular the season cookies. These store a so-called season ID, with which different requests from your browser can be assigned to the common session. This will allow your computer to be recognized again when you return to our website. The season cookies are deleted when you log out or close the browser.
- c) Persistent cookies are automatically deleted after a specified period, which may differ depending on the cookie. You can delete cookies in the security settings of your browser at any time.
- d) You can configure your browser setting according to your wishes and, for example, refuse to accept third-party cookies or all cookies. Please be aware that you may not be able to use all features of this site.

### § 3 Your rights

- 1. You have the following rights with respect to the personal data concerning you:
  - right to information,
  - right to rectification or deletion,
  - right to restriction of processing,
  - right to object to the processing,
  - right to data portability.
- 2. You also have the right to complain about the processing of your personal data by us to a data protection supervisory authority.

## § 4 Use of Google Analytics

- 1. This website uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses so-called "cookies", text files that are stored on your computer and that allow an analysis of the use of the website. The information generated by the cookie about your use of this website is usually transmitted to a Google server in the USA and stored there. However, if IP anonymization is activated on this website, your IP address will be shortened beforehand by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be sent to a Google server in the US and shortened there. On behalf of the operator of this website, Google will use this information to evaluate your use of the website, to compile reports on website activity and to provide other services related to website usage and internet usage to the website operator.
- 2. The IP address provided by Google Analytics within the framework of Google Analytics will not be merged with other data provided by Google.

### § 7 Use of Google reCaptcha

We use "Google reCAPTCHA" (hereafter referred to as "reCAPTCHA") on our website. Provider is Google Ink., 1600 Amphitheater Parkway, Mountain View, CA 94043 USA ("Google"). With reCAPTCHA we check whether the data entry on our website (for example in a contact form) is done by a human or by an automated program. For this, reCAPTCHA analyzes the behavior of the website visitor based on various characteristics. This analysis starts automatically as soon as the website visitor enters the website. For analysis, reCAPTCHA evaluates various information (for example: ID address, website visitor's visit time on the website or mouse movements made by the user). The data collected during the analysis will be forwarded to Google. The reCAPTCHA analyzes are completely in the background. Website visitors are not advised that an analysis is taking place. Data processing is based on Art. 6 para. 1 lit.f DSGVO.
